In January 2024 I will review the current business support structure, along with the Business plan. This will consider changes in the Village, reduction in Beneficiaries, and Legatees at pre covid roles, along with considering what support is required to committees.

Chairman's Message - November 2023

In my final newsletter to all Legacy Clubs, Legatees, staff and volunteers as Chairman of Legacy Australia, I would like to send a very sincere thank you to each of you for the support that you have given to me, the Legacy Australia Board and all our beneficiaries over the past twelve months. We have had an exceptionally busy time with TLCTR as well as continuing to manage the day-today activities of supporting normal Legacy Club functions.

Since the completion of the AGM and the National Conference I have had time to reflect on the past few years which has covered many areas of Legacy activities and administration.

There have been several "first" events. These events have included a significant response from major Defence contractors to provide funding for TLCTR and



other beneficiary projects; there has been firm indications of ongoing support for Legacy. Some Clubs have already benefitted from these companies with significant financial support for junior education grants, assistance with grants for holiday camps and some emergency relief funding.

We have completed several visits to the Governor General who, with his wife, Mrs Hurley, have continued and re-affirmed their ongoing support to Legacy; this augers well across our nation with several public presentations made by the Governor General. In addition, our CEO and I have travelled to Canberra many times for meetings with the CDF and each of the Chiefs of the Navy, Army and Air Force. These visits culminated in another "first" where, at the Gala Dinner following the National Conference, the Governor General, Chief of the Defence Force, Chief of Army Chief of Air Force and a representative for the Chief of Navy were in attendance. The attendance of these Officers highlights the high regard that Legacy is held within the Commonwealth and our Defence Force.

Over many years some of our older Legatees have expressed views on how long actions take within Legacy to finalise projects or activities. Fortunately, over the past twelve months we have had committees progressing the 2030 Project, the Service Beyond Service and the National Investment Fund project. Each of these are nearing a final resolution. I would like to thank the Legatees and LA Inc staff who have been involved in each of these projects; a considerable amount of personal time and effort has been given by all concerned to bring about outcomes which have been unanimously accepted at the National Conference.

During my time on the LA Inc Board the Directors have always provided serious discussion on achieving a more balanced gender-based Board. This can be more readily achieved from the support of all Legacy Clubs. I strongly request Legacy Clubs to encourage more women join your boards so that they can gain experience with an aim to becoming a Director at the National level.

As mentioned above, LA Inc has had wonderful support from national sponsors for several grants and projects. One has been the recent Kokoda Trail project for some of our "older" juniors. Along with staff member David Gaddes I had the pleasure of recently attending the departure briefings for this activity in Brisbane. I was in awe of these young people for what some of them have experienced in their short lives and what they have achieved despite some very harrowing experiences. All these young people had a very positive outlook and are fine examples of the younger generation for which Legacy provides assistance.

National Chairman's Message 29 November 2023



As each of you are aware TLCTR has reached the finale with what I believe, great success. I know that all of us experienced some trepidation leading up to the event taking place in the individual localities, however the feedback that I personally received at each location, or shortly after, was that all Legacy Clubs were exceptionally happy with the eventual outcomes.

We enthusiastically approached TLCTR with hope that the overall profit would be in the vicinity of several million dollars, however as a result of COVID and other global financial changes this did not eventuate. As a direct result of TLCTR, Legacy has benefitted from funds of over \$600K which have already been dispersed to several Legacy Clubs for education, Junior Legatee camps or youth development grants. In addition, one Defence contractor has committed to increased funding of approximately 50% based on previous years support. Other Defence contractors have indicated an ongoing commitment to Legacy. Further to this support we have had an increase of funds from one of our long-term benefactors for youth development and emergency support to beneficiaries; these funds have also been distributed to several Legacy Clubs.

The final outcome of cost and funds resulting from TLCTR will not be available until the end of this current financial year as some committed funds have not been received. This information will be available to Clubs at this time.

Another outcome of TLCTR is that of increased interest shown from people who would like to become Legatees or assist Legacy in the work that we do. There have been many enquiries regarding becoming Legatees which has resulted in new inductions in several Clubs. I have been advised that there has been between four and fifteen new Legatees in some Legacy Clubs. This was especially noticeable from members of the Defence Force who assisted on the many legs of TLCTR and it has been exceptionally pleasing that some of these young service men and women have either completed their applications or are in the process of being inducted as Legatees.

After the National Conference, Centenary Dinner and AGM I received many accolades for Legacy from attendees at each event regarding their success. This can be attributed to each of you for your participation and input, also to the hard work given by the LA Inc and Melbourne Legacy staff who worked tirelessly to ensure the success of these events. I have received exceptionally high praise for Legacy from the Governor General and Mrs Hurley as well as CDF and each of the Defence Chiefs.

In finishing my tenure as Chair of Legacy Australia I would like to thank each of you for the efforts that you have given to Legacy and our beneficiaries and also for the support that has been extended to the Legacy Australia Board and staff.

I send to you my best wishes for a very happy and healthy Christmas and an exciting and fun filled 2024.
